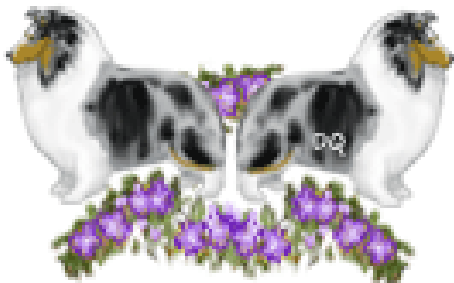

**Non-Regular Classes Involving Single Dog Entries**

Veteran Classes – Class for dogs and class for bitches 7 years or over. Neutered Dogs and Spayed Bitches are allowed to compete in Veteran Classes at Independent Specialty Shows. (AKC Dog Show Rules, Chapter 14, Section 8.)

**Bred By Exhibitor (BBE) Class eligibility (revised 09/02)**

All dogs entered in the Bred by Exhibitor Class must be **individually registered** with the AKC. The person handling the dog must be a breeder of record of the dog and an owner of record of the dog. To exhibit in this class, family members must be a breeder and owner of record.

## Best of Breed Competition

The following categories of dogs may be entered and shown in Best of Breed Competition: Dogs that are Champions of Record; and Dogs that are Champions of Record which according to their owner's records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If, at the end of the 90 day period, the championship of a dog has not been confirmed by The American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by the AKC.

**Award of Merit:** At his/her discretion, the judge may present one Award of Merit rosette for every seven entries in Best of Breed competition excluding Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog, Select Bitch, Winners Dog & Winners Bitch, that by virtue of their placement, have already been recognized.

## SWEEPSTAKES

**CLASSES:** Puppy Sweepstakes shall be divided into six age classes (as named below) three for each sex and judged down to fourth place. Veteran Sweepstakes shall be divided into four age classes (as named below) two for each sex and judged down to fourth place.

### PUPPY SWEEPSTAKES

**Fee \$10.00** which is added to the regular entry fee. Entry is made by marking in Additional Class on the regular entry form "Sweepstakes" and the age class. All entries in the Sweepstakes must also be entered in a Regular Class.

#### Classification

Puppy Dogs, 6 months & under 9 months	Puppy Bitches, 6 months & under 9 months
Puppy Dogs, 9 months & under 12 months	Puppy Bitches, 9 months & under 12 months
Dogs, 12 months & under 18 months	Bitches, 12 months & under 18 months

**BEST IN SWEEPSTAKES:** Shall be chosen from the first place winner of each of six above classes.

**RUNNER-UP TO BEST IN SWEEPSTAKES:** Shall be chosen from remaining finalists and second place from the class of the BIS Winner.

**ELIGIBILITY:** The Sweepstakes shall be open to any Shetland Sheepdog eligible for competition in the regular AKC classes whose age will be no less than six months and under eighteen months on the day of the judging. The exception to this rule is as follows: No Dog which has completed the requirements for a championship prior to the date of judging shall compete in the judging of the sweepstakes.

**INELIGIBLE DOGS:** Should it be that an ineligible dog has received an award in the Sweepstakes, the person to whom such award was presented shall make restitution to the Club and such award shall be deemed to have been won by the dog judged second to the dog declared ineligible. The prize money and other awards shall then be redistributed to conform to the rules.

### VETERAN SWEEPSTAKES

**Entry fee is \$13.00** as an additional or only class. Veteran Sweepstakes is open to all Shetland Sheepdogs eligible for competition in the regular AKC classes, which on the day of the show will be at least seven years of age. Veteran Sweepstakes entries need not be entered in any regular or non-regular classes. Entrants do not need to be titled to compete and sexually altered veterans may compete.

Judges for this class must be approved to judge Novice or higher classes. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. However, if a person has handled more than one dog in the first five exercises, that person must provide a handler for the additional dog in the same Long Down exercise. If eligible as defined in these regulations, dogs entered in Graduate Novice may also be entered in any other obedience classes.

Move-Ups will be accepted if made in writing to the Show Secretary at least 30 minutes prior to the commencement of judging.
